# Resolution of the Portage County Records Commission regarding 2024 public meetings

Pursuant to Section 149.38 of the Ohio Revised Code the Portage County Records Commission is to meet at least once every six months and upon the call of the chairperson. The Records Commission designates **February** and **August** as the months in which the statutory prescribed meetings will occur. The Records Commission will provide notice of the **February Meeting** and the **August Meeting** (as well as any other special meeting that may be called by the chairperson) by the method described as follows:

NOTICE for the February Meeting and NOTICE for the August Meeting (as well as any other special meeting) will be posted on bulletin boards on the First Floor and Seventh Floor in the Portage County Administration Building and on the County's website at

The Secretary of the Portage County Records Commission shall notify the Record-Courier of the date, time, place, and purpose of the February Meeting and the August Meeting (as well as any other special meeting that may be called by the chairperson) at least 24 hours in advance of the February Meeting and the August Meetings (as well as any other special meeting). If any other news media have requested notification, the Secretary shall give at least twenty-four hours advance notice to any other news media that may have requested notification.
