Hal Stamm stated with the condition being to abide by the zoning conditions and Douglas Brown seconded. Frank Horack added that the owners go through the Building Department with the regulations on the prints. Roll call taken, variance passed. Hal Stamm moved to adjourn, Audrey Kessler seconded. Meeting adjourned.
